State seeks public comments, sets hearing for air permit on Atlantic Coast Pipeline project

RALEIGH – The North Carolina Division of Air Quality today opens a public comment period for a minor source air quality permit for the proposed Northampton Compressor Station, which would serve the Atlantic Coast Pipeline project.

If the air permit is approved, the compressor station would regulate operation of air emissions sources and air cleaning devices. The station is proposed to be at 718 Forest Road, Pleasant Hill in Northampton County.

All public comments received by Nov. 20 will be considered in the final determination regarding permit issuance and permit conditions. The draft permit, application and related documents are available online at: <https://deq.nc.gov/about/divisions/energy-mineral-land-resources/acp>.
