**New Laws for League**

Be it enacted that Monthly dues be raised from 25¢ per. month to 50¢ per. Month to become in effect April 1<sup>st</sup> 1924.

Be it enacted that the members of League in case of Sickness shall receive \$5 per week for first 2 weeks \$3 per week for next ensuing 3 weeks And if said member or members continue sick they shall from time to time be considered by the Lodge.

Be it enacted that any member must be fianancial before they can be entitled to any benefits from the treasurers of the Lodge.

Be it enacted that before any member is entitled to any sick benefits from the League they must at Least be confined to their room And on presenting their Dr. Certificate shall receive the benefits due them.

Be it enacted that in case of death the survivor shall receive \$50 for burial expenses.

Be it enacted that any member who have allowed themselves to become 6 month back in their monthly dues shall be deem unfianancial And excluded from all benefits from the League.

Be it enacted that no member shall be allowed if he is unfianancial to make himself or herself fianancial while sick.
